Olympic Training Camp – Dover Leisure Centre – December 29th & 30th

Congratulations you have been selected to take part in this year's Olympic Training camp at Dover Leisure Centre on December 29th & 30th, 2021. There will be a charge of £15 per participant as a contribution to the cost which as you can appreciate is significantly underwritten by East Invicta. It will be hosted by British Olympic Coach David Hemmings,

Team Manager will be Mike West from Herne Bay.

You will be required to arrive at the leisure centre at 0830hrs. Parents are welcome to stay and watch during the pool and land based activities. The event will finish on Thursday afternoon. There will be a short debrief session at the end, so swimmers should be ready to leave by about 1700hrs. During the camp there will be land training sessions and two pool swimming sessions each day.

Athletes will be required to bring at least two towels and swimming costumes each day, normal pool training equipment, lace up training shoes, shorts and tee shirt, track suit and sweat shirt. Meals will not be provided so swimmers should bring with them enough food for the day and at least 2 litres of fluid (not fizzy drinks!!!). This can of course be concentrate as facilities will exist for making up drinks.

All children who attend are required to have a completed medical consent form which should be returned with the booking form to your club contact
